The Compliance Committee was formed in 2014 to address insurance and such other compliance and management issues faced by The Continental Line, Inc. (the "CL") that may be assigned to it by the Chairman and/or Board of Directors, or otherwise undertaken for the benefit of the CL. The Committee currently consists of the three Departmental Coordinators and Mr. Weaver (the author of this report). The following issues addressed by the Compliance Committee and its Chairman in 2022, are of note:

7. Forwarding a list of 250th Anniversary Boards and Commissions prepared by the Omohundro Institute of Early American History and Culture, in Williamsburg, Virginia.
