







Proposal for a National Event:
240th Anniversary of the Battle of Hobkirk's Hill
Kershaw County, South Carolina
November 13-14, 2021

Sponsored by the 2nd South Carolina and 7th Regiment of Foot In conjunction with the Southern Campaign 1780 and Liberty Live

Objective: Reenact Historical Battle; Funding for Education Programs; and provide an outstanding experience for participants, students, and spectators to the event site during the annual reenactment weekend for the purpose of bringing our fight for liberty to life.

Venue and Access

Private property in a very rural area of Kershaw County.



Modern: 1 building and one power line through center of property. Modern sprinkler system in battlefield that was hidden by corn stalks. No football stadium, no sounds of the highway or road, no sirens, no ambient light (a star gazer's paradise)

Camping area is a large mowed field with plenty of room. Woods are open in some places, very suitable for progressive reenactors or cavalry camping.

Site is approximately 15-20 minutes from I-20; 15 minutes from the Town of Camden. The route is marked with signs once you drive on state roads outside of Camden

Amenities


- Town of Camden

Terrain



Terrain: 550 acres of private property.

Battlefield is 20 acres of plowed cornfield.

Forested areas are mixed with open underbrush and some areas with medium to heavy underbrush.

Roads are sandy and have some bumps in them.

All areas are open to 18th-century camping/progressive camping/campaign camping

Ponds on property but are normally out of play.

Owner's residence area is out of play

- May Meeting to address/ & recruit getting staff (Captains) for specific planning coordination areas
- June Kick off Planning Meetings
- July Solutioning of "Considerations" begins
- Aug Begin regular planning meetings Keeping Separate from Board Meetings



Why come to Kershaw County?

- Over 500 acres of rural woods and field for camping and battle, allows for any scenario desired
- Owner adaptable and willing to work with reenactors
- Private property, no state or national park rules
- 2020 saw 750 students on education day; 450+ reenactors; 350 Sutlers (25 shops) and demonstrators; and 1200 spectators during COVID
- Event will deconflict with the World War 1 Event in PA
